Dear Junior Counselor Applicant:

Thank you for showing your interest in working at YMCA Camp Greenville for a portion of Summer 2008. Working at Camp Greenville will show you another side of Camp; very different from when you were a camper. We want to make sure that applicants have all the necessary information in order to make the best decision for themselves. The following is information that will help you make the decision if applying at Camp Greenville is the best fit for you:

- A very limited number of Junior Counselor positions are available. We receive more applications than slots, so the process will be very competitive.
- Applicants applying for the Front 4 are required to attend a mandatory staff training the weekend of May 16th – 18th. If you cannot attend, then the front half may not an option. Contact Matt to discuss this matter further. Those applying for the Back 4 will receive training when they arrive at camp.
- Junior Counselors will not be able to leave camp during their six-hour time-off. Opportunities for relaxation and fun will be provided at camp during that time-off.

To apply, the following forms must be completed and returned to Camp:

- YMCA of Greenville Application
- Junior Counselor Application Addendum
- Background Check Form
- Voluntary Disclosure Form
- 3 Completed Reference Forms

Applications will not be considered until all forms are completed and returned.

Information for Junior Counselor Applicants

- All staff are required to participate in staff training/orientation. If your schedule does not allow for you to attend one of these sessions, then we may not offer you employment. Please note that the training for the “Front 4” is a weekend before the summer starts.
- CPR, First Aid and AED certification is a condition of employment for all summer staff. It is your responsibility to obtain these certifications prior to your arrival at Camp. Certifications must remain valid through the end of your employment.
- All staff are required to have had a physical within 12 months of beginning employment and have a copy of the Camp Health Form on file prior to beginning work.
- In order to be eligible for employment, each applicant should have copies of his or her certifications and Health Form on file before beginning work.
- In accordance with the standards of the American Camping Association, only 20% of the staff may be younger than 18 years old. (This limits the number of Junior Counselor positions available at any given time.)
